To become an FSMC/Vendor in Illinois, the company will need to comply with the State of Illinois Secretary of State and the Department of Public Health to ensure the business has the appropriate licensing for operating as a an FSMC and/or Vended Meals company.

The company will also need to ensure it can comply with the rules and regulations set forth in the Federally Funded Child Nutrition Programs. Please visit our <u>website</u> for information on the Child Nutrition Programs.

Once the company has met the requirements above, they can notify ISBE that they would like to be included on their list of known FSMCs/Vendors and may be contacted in their future solicitations for meal services. The company cannot engage in any further "selling" of their services (including consultation, phone calls, presentations at school boards, etc.) directly to Child Nutrition Program participants as there are state and federal procurement regulations that prohibit that.

ISBE also maintains this list of potential known FSMCs/Vendors to aide our School Food Authorities (SFA) in their solicitation process. The list is not all inclusive and each SFA has a right to solicit from companies not listed within who can meet their needs while complying with all Federal rules and regulations of the Child Nutrition Programs. <u>Food Service Management Companies (FSMC)</u>: An FSMC contract is one in which the contractor manages some aspect of the school food service program. The FSMC prepares and serves the meals and/or manages the school meal program(s).

<u>Food Service Management Companies-Vended Meals (FSMC-Vended)</u>: An FSMC- Vended contract is one in which the contractor manages some aspect of the school food service program. However, the SFA does not have adequate cooking facilities and therefore the FSMC prepares the meals (pre-packaged or in bulk) off-site in their commercially owned or rented facility, delivers the meals to the SFA, and serves the meals and/or manages the school meal program(s).

<u>Vended Meals Companies (Vended)</u>: A vended meals contract, the contractor provides the meals only (generally pre-packaged/pre-plated) and does not manage any aspect of the school food service. However, if the contractor's employees are responsible for the management of the program and/or for the final preparation and/or serving of pre-packaged/pre-plated school meals, the contract becomes a FSMC contract and is no longer considered a vended meals contract.
