I. Background

The Village prepared this report to satisfy the requirements as outlined in Section 66.10013 of the Wisconsin Statutes. Section 66.10013 reads as follows:

- (1) In this section, “municipality” means a city or village with a population of 10,000 or more.
- (2) Not later than January 1, 2020, a municipality shall prepare a report of the municipality's implementation of the housing element of the municipality's comprehensive plan under s. 66.1001. The municipality shall update the report annually, not later than January 31. The report shall contain all of the following:
 - (a) The number of subdivision plats, certified survey maps, condominium plats, and building permit applications approved in the prior year.
 - (b) The total number of new residential dwelling units proposed in all subdivision plats, certified survey maps, condominium plats, and building permit applications that were approved by the municipality in the prior year.
 - (c) A list and map of undeveloped parcels in the municipality that are zoned for residential development.
 - (d) A list of all undeveloped parcels in the municipality that are suitable for, but not zoned for, residential development, including vacant sites and sites that have potential for redevelopment, and a description of the zoning requirements and availability of public facilities and services for each property.

- (e) An analysis of the municipality's residential development regulations, such as land use controls, site improvement requirements, fees and land dedication requirements, and permit procedures. The analysis shall calculate the financial impact that each regulation has on the cost of each new subdivision. The analysis shall identify ways in which the municipality can modify its construction and development regulations, lot sizes, approval processes, and related fees to do each of the following:
 - 1. Meet existing and forecasted housing demand.
 - 2. Reduce the time and cost necessary to approve and develop a new residential subdivision in the municipality by 20 percent.
- (3) A municipality shall post the report under sub. (2) on the municipality's Internet site on a web page dedicated solely to the report and titled "Housing Affordability Analysis."

THE VILLAGE LISTS THE ZONING REQUIREMENTS FOR DEVELOPMENT OF EACH LISTED PARCEL IN CHAPTER 90 OF THE MOUNT PLEASANT CODE OF ORDINANCES.

5. Section (e): An analysis of the municipality's residential development regulations, such as land use controls, site improvement requirements, fees and land dedication requirements, and permit procedures. The analysis shall calculate the financial impact that each regulation has on the cost of each new subdivision. The analysis shall identify ways in which the municipality can modify its construction and development regulations, lot sizes, approval processes, and related fees to do each of the following: 1) Meet existing and forecasted housing demand. 2) Reduce the time and cost necessary to approve and develop a new residential subdivision in the municipality by 20 percent.

5.1. Analysis

5.1.1. Construction and Development Regulations

One may find the Subdivision requirements for residential development in Chapter 74, Article III: Design Standards of the Mount Pleasant Code of Ordinances¹. The ordinances closely follow those recommended in SEWRPC's model subdivision ordinance and are relatively uniform with adjacent municipalities. Therefore, while the subdivision requirements may affect the total cost of constructing a residential unit, staff do not believe they likely affect the comparative price of building a new unit.

In 2020, the Village rewrote its zoning ordinances to remove the high-density districts' requirement for covered, under-building, or underground parking. The removal of this requirement, paired with a general reduction in mandatory parking minimums, now lets the housing market determine the parking required per specific project. Additionally, the Village allowed developers to count nearby shared or on-street parking towards their parking minimums, which allows additional parking flexibility and potential cost savings. As discussed in the 2019 report, "The average cost of such parking varies by both type (e.g., standalone garage vs. underground) and by civil engineering required to install

it; however, the cost of an outdoor space may range between \$5,000-\$10,000, while a garage space may range between \$25,000-\$50,000². The minimum difference of \$15,000 between the two ranges, when applied to a 36-unit apartment building, would increase the cost of construction per unit by \$15,000, or \$540,000. Using an average new, multi-family, per-unit total cost of construction of \$180,000, the cost of structured vs. unstructured parking alone would change the unit's price by 8.3%. Staff also note this does not consider differing civil and structural engineering design and construction costs of either raising or sinking a parking structure within a building.”³

In conversations with long-standing, local developers who have watched local project costs change year-over-year, staff received many complaints regarding the costs of labor and materials. Labor prices are subject primarily to market conditions, state law, and federal law, and the Village cannot widely affect such prices. Similarly, material prices are subject to the same market forces, and the Village is itself subject to cost increases for raw materials such as stone or asphalt. For example, both the prices of stone and asphalt increased higher than the inflation rate over the past few years.

The Local Street Typical Detail for Village public streets already includes cost-saving measures, such as using mountable curbs. Developers could realize some cost savings on public streets if the Village narrowed the standard cross-section by two feet. The current cross-section is 32 feet, plus five feet of mountable curbing (two and a half feet per side). In this cross-section, the Village typically allocates the traveling public 11 feet per lane and 7.5 feet per parking lane (some of which is curbing). Reducing the cross-section by two feet to 30 feet would allow for 10-foot lanes and reduce the cost of constructing a public street by the corresponding aggregate base and asphaltic concrete pavement. Per linear foot, this reduction would result in a cost savings of approximately 6%, using the prices of the 2020 Village paving program.

5.1.2. Home Sizes

The Village's 2020 zoning code rewrite also significantly reduced the minimum home size required in the “standard” subdivision zoning, RL-1 (Residential Low Density 1). The rewrite reduced the former minimum home sizes in the former R-100 and R-75 districts of 1,500 ft² and 1,800 ft², respectively, to a unified 1,250 ft². The decrease in the construction cost between these minimum sizes, when using a construction cost of \$115.50/square foot, is approximately \$29,000 between the R-75 and RL-1 minimums and \$63,500 between the R-100 and RL-1 minimums. Reducing the minimum home size in the RL-1 district reduced the cost for a new unit by approximately 17% between the R-75 and RL-1 minimums and 31% by the R-100 and RL-1 minimums. Additionally, the RL-1 district does not have a minimum home size when not adjacent to existing homes, and the RL-2 district does not have a minimum home size universally. These reductions allow much greater home size, and thus, cost of construction flexibility. The remaining costs of home construction include market-driven costs, such as costs of materials and labor primarily. The Village does not control these costs through local regulation and typically does not publicly incentivize single-family construction.

5.1.3. Fees and Dedication Requirements

In 2017, the Village, as a part of an updated agreement with the City of Racine Water and Wastewater Utilities, was able to lower the cost of a water connection fee (REC Fee) from \$3,600 to \$500. This total cost savings over the price of a \$245,000 home is approximately a 1.3% reduction in cost. Total development fees for a new, \$245,000 home, as listed in the 2019 New Housing Fee Report, total roughly \$9,305.40, or 3.8% of the total cost of the house.

The Village requires land preservation only adjacent to navigable waterways and streams, such as the Pike River or Hood's Creek. Floodplains or wetlands often cover such areas and are usually not easily developable regardless. The

Village accepts public parkland dedication in place of park impact fees, which total \$1,100 if the land lies within the parkland area identified on the Village’s Comprehensive Outdoor Recreation Plan.

The charts above show the existing rental housing in the Village is affordable for a household of four as defined as below \$1,566 (80% AMI). The most significant number of rental units in the Village by type are two-bedroom units between \$750 and \$999, which would come very close to affordable for those making 60% of the AMI for families of two or fewer. For owner-occupied housing, the market values 54.6% of the owner-occupied housing stock under \$200,000. This value qualifies as affordable for four-person households at 80% AMI. The market values 31.7% of the owner-occupied housing stock under \$150,000, which qualifies as affordable for four-person households at 60% AMI. 76.9% of total housing stock in the Village was constructed before 2000, which may explain the general affordability of the Village for those making at or less than the AMI. However, staff notes the slowdown in construction may affect the long-term affordability of the Village if population growth continues while housing stock growth remains slow. The 2010s added the lowest percentage of new housing stock by decade at 2.2%, compared to the 20.8% added between 2000 and 2009.

5.2. Meeting existing and forecasted housing demand

“In 2010, there were 26,197 residents and 11,136 households in the Village. The Wisconsin Department of Administration’s population estimate for the Village in 2019 is 26,976 residents. Based on VISION 2050 population forecasts, which includes the Foxconn development, the plan forecasts 44,700 residents and 19,700 households in the Village of Mount Pleasant in the year 2050. The forecasted population of 44,700 residents is the amount upon which the needs analysis presented in this chapter is based. Under the plan, the number of Village residents would increase by 18,503 people, or by 71 percent, and the number of households would increase by 8,564 households, or by 77 percent, between 2010 and 2050.”⁷

Subtracting the estimated net 261 housing units created between 2010-2019 gives 8,303 total required households to meet the SEWRPC estimated population increase by 2050. An increase in 8,303 households, at the minimum lot size of the RL-1 district (6,000 ft²), would require approximately 1,144 acres. If adjusted by an extra 15% to account for required roadway and stormwater facilities, the land required for housing development totals 1,316 acres or just over two square miles. The closest Wisconsin municipality to this size and population is Whitefish Bay, in northern Milwaukee County. Thus, to meet the projected housing increase, the Village should encourage housing development of approximately one Whitefish Bay within its boundaries in the next 30 years.

5.3. Reducing the time and cost necessary to approve and develop a new residential subdivision in the municipality by 20 percent

The Village has stated approval deadlines within Chapter 90 of the Mount Pleasant Code of Ordinances. These deadlines run close to, if not right up against, the minimum deadlines required by state law due to public noticing requirements. The Village adopted simplified development applications and keeps an updated, standard Development Agreement for subdivisions to minimize legal timelines. Therefore, it would be challenging for the Village to reduce further the time necessary to approve a new residential subdivision. Staff note a portion of the review time for subdivisions also lies in the review process of objecting agencies, which the Village does not control.
